**Confidentiality and safety:** **A.** All matters discussed with the psychotherapist are confidential, except in any of the following circumstances, which are required or permitted by law: **1.** When the client gives written permission for the therapist to share specific information with others (e.g. physician or insurance company), **2.** When the therapist has reason to suspect that a child, elderly person, or dependent adult in the client’s life has been physically, sexually, emotionally, or financially abused, **3.** If the therapist has reason to believe that the client intends to physically harm another person or persons, or **4.** If the therapist has reason to believe that the client is acutely suicidal, the therapist will take measures necessary to protect the client’s safety, including breaking confidentiality. **B.** The client understands the limitations of therapy, that there can be no guarantees of success, and that the client may occasionally experience discomfort or feel worse during the course of treatment. **C.** During the use of electronic communication, including but not limited to online video sessions or email, the client understands there may be increased limitations of client confidentiality. **D.** When using electronic communication for treatment, the client agrees to provide current information for local emergency contact and client location.
